DREAM GYMNASTICS POLICIES: Please initial that you have read and understand the following:

___ COMMUNICATION

We use email and social media as our two main sources of communication with our Dream Families. Please keep a current email address on file. You may need to check your SPAM folder as emails sometimes get sent to that folder! Inclement weather closings, account information and special announcements are sent via email!

___ PARENT OBSERVATION

Parents are not allowed inside the facility to view class. Parents may observe gymnasts during class from outside via the windows. **The only exception is for Preschool class parents and Parent and Tot parents.** Parents are not required to stay at the facility during their child's class but agree and acknowledge that they will pick up their child ON TIME (If student is repeated picked up late, a late fee penalty will be applied.)

___ STUDENT WITHDRAWAL

Please be advised that Dream Gymnastics policy states that a 30-day written notice of withdrawal is required to cancel classes. When you register for class, you are enrolled each month until we receive notice of withdrawal. Upon withdrawal from the program, we will stop processing your card on file and tuition obligation is relieved.

___ MAKE UPS

Tuition is not prorated for absences. We understand that unexpected occurrences arise and we offer make ups as a courtesy. Students are permitted to make up one (1) class per month, regardless of the number of classes missed. Make up classes are not needed for scheduled closings as they are factored into tuition. Make up classes must be scheduled through our office via email, dreamgymnasticsnc@hotmail.com.

___ TUITION AND REGISTRATION

Dream Gymnastics begins each season in September and continues through May. Summer programs are June through August. There is a \$40 non-refundable registration fee due per child upon enrolling (\$70 per family). Registration fees are prorated beginning in January (due to late entry). ALL students will be charged a yearly registration fee.

Tuition payments are due on the 2nd day of each tuition month. After the 7th day of the tuition month, a \$10 late fee must accompany the late tuition. You may pay tuition by cash, check or credit/debit card. Monthly tuition is based on a 4-week month. Some months that exceed 4 weeks will carry over to the following month to even out each month due to gym closures for the holidays. December and May are the only exceptions and will be prorated. Tuition is not based on attendance, but instead on enrollment.

Dream Gymnastics requires each family to keep a credit/debit card on file for the purpose of account settlement. If TUITION is at least 30 days overdue, and no special payment or withdrawal arrangements have been sent to Dream Gymnastics, then the overdue TUITION amount and LATE FEE amount may be rightfully and automatically drafted from the credit card on file.

___ AUTO DRAFT

Tuition payments will be drafted on the 2nd of each tuition month. I understand that Dream Gymnastics will automatically charge my monthly tuition by the 2nd of each tuition month until (1) the conclusion of the September 2024-May 2025 season, or (2) the 30-day written withdrawal notice has been received.

I hereby release, discharge, and covenant not to sue Dream Gymnastics, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which any of the Dream Gymnastics activities take place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the
